

## **ABSTRAK**

### **PENERAPAN SANKSI PELANGGARAN PERATURAN DAERAH COVID YANG DILAKUKAN DALAM YUSTISI**

Pandemi *Corona Virus Disease 2019* yang disingkat menjadi Covid-19 yang melanda Indonesia sampai sekarang belum reda jua. Update terakhir Organisasi Kesehatan Dunia (WHO) mengkonfirmasi bahwa virus corona bisa juga menular melalui udara alias airborne. Disebutkan bahwa beberapa studi melihat bahwa ada kemungkinan droplet berukuran ekstra kecil yang dihasilkan saat batuk atau bersin dapat membuat virus bertahan di udara terkait cara baru penularan *Corona Virus Disease 2019* (Covid-19) melalui udara. Permasalahannya: a. Bagaimanakah penerapan sanksi pelanggaran peraturan daerah covid yang dilakukan dalam yustisi?. b. Berdasarkan hasil penelitian dan pembahasan, maka kesimpulannya adalah: 1. Sanksi bagi pelanggar protokol kesehatan mengacu pada Peraturan Wali Kota di Kota Metro. 2. Faktor penghambat penerapan sanksi pelanggaran peraturan daerah covid yang dilakukan dalam yustisi yaitu pemahaman dan disiplin masyarakat masih kurang dalam penerapan protokol kesehatan, perlu ada edukasi terus menerus.

Saran penulis adalah 1. Gaya komunikasi kepada masyarakat perlu diperbaiki. Selain itu, pemerintah atau pihak terkait untuk menangani masalah itu ikut terjun kelapangan dalam eksekusi, karena masyarakat akan patuh jika pemimpin benar dan konsisten atas apa yang disampaikan. 2.
